
Please refer to your application dated 23.05.07 via E.mail received in this office on 01.06.07 regarding clarification to the reply submitted by this office dated 15.03.07. The desired information/ clarification is given as under:

1. Road No.226 is still not connected because part of land is still un-acquired for which matter taken up with Director(Land).
2. The grills have been provide as per approved drawing issued by Sr.Architect.
3. The work for carpeting the lanes of sector-22 shall be taken up after the end of monsoon season. Lanes of Sector-23 have already been carpeted.
4. The removal of malba cropped up from Civil & Horticulture work is the responsibility of DDA and same is removed before completion of work.
5. The site for Automobile show room (Magic) at Plot No.94 Sector-20 was auctioned by DDA for commercial use with ground coverage 30% only & 70% set back to be left open in front & rear of the built up portion and Automobile show room is using the set back on their own plot and not on the public land. However as precautionary measure EE has taken up the matter with SHO also.
6. The tree guards in most of the sapling have been fixed where there is risk of damage of sapling. Most of the damaged trees have been replaced.

7. The tree guards will be provided during the next two months and same shall be removed after full growth of trees.
8. Six months after expiry of contract, the damaged plants are replaced by the agency and after six months resapling in place of lost/ damaged plant is done by DDA.
9. Reply is being sent to you separately by SE(HQ)Elect. P.I.O.
10. The concerned EE has taken up the matter with Director(Plg.) Dwk regarding installation of Dwarka Map.
11. Yes all the press clipping pertaining to DDA are replied regularly.
13. The malba in the parks have already been removed and at present they are neat & clean. Daily attendance of staff posted there is taken. One security guard has been posted for the watch & ward of parks. The uniform have been given to security guards & Mates.
14. Nos. of illegal boards, banners, posters are removed regularly.
