
Sir,

Please refer to your application I.D. No. 553 dated 24/04/2007, seeking information under Right to Information Act 2005. The point wise reply is given as under: -

1. Health Deptt, Najafgarh Zone takes action as per DMC Act for violating health related activity and any resident is free to make complaint on MCD Services to citizen.
2. Name of the officials, who were assigned to do survey/inspect/monitor areas regularly, under, Najafgarh Zone of Health Deptt. , Vet. Deptt & Sanitation Deptt. is as under: -

3. It will be decided by the Competent Authority, as per rule.
4. (a) The complaint No. 377/ VRC has been attended by the concerned AMI.
(b to d) The said complaint have not been attended by the M.C.D. Najafgarh zone.
(e) The complaint No. 851/LJL dt. 11/03/05 attended by Veterinary Deptt. of Najafgarh Zone and a raid conducted by this department over stray dogs, but there was no dogs found at the site.
(f) The said complaint was not attended by the Building Department, M.C.D./NGZ
5. No other work like construction road, drain & replacement of manhole covers etc. has not been taken over from DDA till date.
6. In this connection, it is to inform you that plying of cycle rickshaws within Municipal jurisdiction of governed in pursuance of provisions of the Cycle Rickshaw Bye-laws, framed under Section-481 of the D.M.C. Act. 1957. In pursuance of policy framed by the Corporation vide its resolution No. 217 dated 1/12/1997, zone-wise ceiling has been fixed towards licensing of cycle rickshaws in Najafgarh Zone, there is a ceiling for grant of 8,000 cycle rickshaw licenses, out of which 7235 licences have been granted for the entire jurisdiction of the Najafgarh Zone and Dwarka is one of the part/area of the Najafgarh Zone. To check the plying of illegal cycle rickshaws, raids are conducted on regular basis by the Hackney Carriage Section of the Najafgarh Zone, on realization of a prescribed fine of Rs. 300/- per rickshaw plus Rs. 25/- per day, per rickshaw toward storage charges.
7. The action is being taken by M.C.D., Najafgarh Zone from time to time for removal of temporary as well as permanent encroachment. The matter is mainly related to Delhi Police for smooth flow of traffic. For removal of encroachment by MCD action is being taken from time to time, for removal temporary as well as permanent encroachment.

8. All the staff of Veterinary Department are responsible for it.
9. Malaria Deptt. regularly carried out anti-larval, DBCs, Houses spray, health education activities to fight with Dengue and Mosquitoes. On request and emergency, fogging is being do through hand operated machine. Fogging through Tiffa Machine is started as per orders of Malaria Headquarter.
10. It has already been done, all the departments of M.C.D. Najafgarh zone have already been computerized.
11. No M.C.D. office is exist in Dwarka sub-city.
12. Is there any Customer Services Beuro of M.C.D. in Dwaraka, if so where it is, if not when it would be ready.
13. No such record is maintained in Account Branch, Najafgarh Zone. However on an earlier occasion, as desired by DC/NGZ this information was obtained from the H.O.Ds. upto the period 28/02/07. The copy can be obtained by depositing Rs. 18/- (Rs. Eighteen only) for nine papers.
14. No such information is maintained by Accounts Branch, in respect of other departments. However, the budget allocation letter and expenditure upto date in respect of Accounts Department, Najafgarh Zone. The copy can be obtained by depositing Rs. 12/- (Rs. Twelve only) for six papers.
15. Yes
16. Control Room, Najafgarh Zone, where all complaints are monitoring. The A.P.R.O. received all complaints and sent to the concerned departments.
17. R.W.A. should come forward with there problems on sanitation and other issues ~~in a~~ regular way with the staff of the deptt.
18. In Najafgarh Zone in following localities are doing night sweeping i.e. (i). Mahipal Pur Market, (ii) Najafgarh Town, (iii) Punjabi Basti, Nangloi, (iv) Jalebi Chowk, Sultanpuri (v) Peera Garhi Chowk.
